Coordinating the next wave of EU climate policies

Workshop draft outline

Motivation and objectives: A number of progressive EU member states currently are in the process of reforming and ratcheting-up their domestic climate policies. At the same time, the EU is in the process of increasing its 2030 and 2050 emission reduction targets to embark on a reduction pathway towards net zero emissions by mid-century. This raises a number of questions about the design features and expected performance of these domestic policies, and the reform of EU-level climate policies; and on how these domestic policies will interact with EU climate policy – including the EU ETS and the Effort-Sharing Regulation in the non-ETS sectors.

Against this background, the objectives of this workshop are to (1) take stock and analyze recent EU national climate policy reforms including those involving carbon pricing; (2) present and discuss most recent work academic work on recent and potential future EU ETS reform; and (3) identify broader needs and opportunities for future EU climate policy reform to enhance policy coordination and cooperation. Potential outputs of the workshop might be a workshop report or a joint paper offering an overview and update on domestic policy change in several progressive EU member states, and the challenges and opportunities this raises for EU-level coordination and policy reform.
