1.3 Processing of Participant Data

If you attend and participate in an event of the Potsdam-Institut für Klimafolgenforschung (PIK) e.V. ("**PIK**"), "**us**" or "**we**") we process your personal data including your surname, your first name, your profession/employer, your position, your email address, photographic images and video recordings as well as your telephone number if you voluntarily make them available to us. We do not intend to process any special categories of your personal data. If you provide us with such personal data, we will also process such data.

1.4 Purpose and Legal Basis

We will process your personal data for the organization of the event you want to register and sign up for. The legal basis of this data processing is Art. 6 paragraph 1 sentence 1 lit. b) EU-GDPR.

We process photograph images and video recordings due to the justified interests of the PIK pursuant to Art. 6 paragraph 1 sentence 1 lit. f) EU-GDPR, i.e. the interest in the documentation of such events for the purpose of public relations, for the documentation of the certain event and project and for the marketing by PIK.

1.5 Duration of Data Retention (Storage)

We will delete your personal data made available to us for the purpose of participating in an event not later than three years after expiration of the year in which you attended the event.

We will delete your photograph images and video recordings if we do not longer need them for achieving the above-mentioned purpose.

If you have given your consent to a storage period exceeding the one specified above, we will possibly retain and store your personal data for a longer period in accordance with your consent.

1.6 Impacts of Non-Provision

The provision of personal data is required for attending and participating in a PIK-event. You are not obliged to provide us with your personal data. If you do not provide us with your personal data required for the organization of the event, it might be possible that we cannot consider you as participant in the respective event.

1.7 Recipients of Personal Data

We ensure that we disclose your personal data only to persons who have a need to know such data for the purposes described in this data protection information, e.g. external project managers of the respective event.

If you register for our event via eveeno.com, then [eveeno](https://eveeno.com) will also process your personal data for the purposes of your registration at PIK-events. We have concluded a processing agreement with [eveeno](https://eveeno.com) pursuant to Art. 28 paragraph 3 GDPR.

1.8 Rights of the Data Subject and Further Information

If your personal data are processed, then you are a data subject within the meaning of the EU-GDPR and you will have rights vis-à-vis us as controller. In particular, you are entitled at any time to object to the processing of your personal data under Art. 6 paragraph 1 sentence 1 f) EU-GDPR.
